- 1. Entry fees: \$150 per head, \$150 per embryo lot, and \$150 per semen, flush, and pregnancy lot.** Entries that are no shows will forfeit all the entry fees. Entry fees are non-refundable.
- 2. Entries are due April 14th, 2017.** Please send all photos pertaining to entries no later than April 21<sup>st</sup>, 2017.
- Sale expenses not covered by the entry fees will be prorated including advertising, catalog, postage, veterinarian, facilities and any other expense connected to the conduct of the sale.
- 4. Entries will be charged the following costs:**
  - Prorated sales costs. \$100.00 of entry fees will go towards sale costs, and \$50 will go towards entry processing.
  - 7% commission on sales and no sales (6% to sale manager; and 1% to the auctioneer).
  - Expenses charged directly to the consignor including brand inspection, Beef Council, transfers, registrations, etc...
- Entries are limited to registered fullblood, purebred, and percentage Wagyu born between January 1<sup>st</sup>, 2009 & November 1<sup>st</sup>, 2016. Pairs, bred females, open females, donor cows, pregnancies, flushes, bulls, semen and embryos are eligible. Fall calvers selling must be safe in calf a minimum of five months by sale day. Spring calvers must have a calf at side, may be open or rebred. All first calf heifers must calve by 30 months of age. The sale management must clear any exceptions. Bulls, semen, flushes, pregnancies and embryos can be entered but only a limited number will be allowed to sell. Any entries not accepted, entry fees will be refunded.
- All live lots that plan on being present to sell must be checked in by noon on June 8<sup>th</sup>, 2017 at 6821 W Independence Dr., Springfield, MO.
- Consignors are urged to offer services and breeding privileges on all female consignments.
- Cattle must be sound and of good quality. Unsound, bad udders, bad eyes, under conditioned and low quality are subject to acceptance only by the sale management. All pedigrees will be screened at entry time. If you have a question about your pedigree's salability, please call the Passion for Prime sale office or Mercedes Danekas-Lohse at (916) 849-2725.
- Cattle may or may not be present to sell. It is recommended by the sale manager that live entries are present, however it is not a requirement. All live entries will be charged prorated sale and facility costs.
- This is an un-haltered sale. However, if your entries are halter broke, please indicate, as many breeders prefer halter broke cattle, because they are quieter and easier to handle. Any fitting or clipping must be completed prior to arriving at the sale site. Entries will be fed and watered by sale and grounds staff.

11. Sale order will be determined by the sales management.
12. All females must be calthood vaccinated, tested negative for TB, BVD and eligible for interstate shipment. All bulls must be semen, trich & BVD tested and eligible for interstate shipment.
13. Cattle that are no shows will forfeit their entry fees. No sales will be charged prorated sale costs and the no sale commissions of 7%. Legitimate substitutions will be allowed.
14. All registered cattle must be registered prior to entry.
15. All paperwork must go through the sale management office. No direct transfers allowed. Please send your certificates for transfers with your entry forms and entry fee. No proceeds will be dispersed to any consignor until all paperwork is completed and to the JDA office. Proceeds will be paid to consignors only after purchases have been paid for and funds have cleared the bank. Be sure to fill out the **“Make proceeds check payable to” portion of your entry form** to ensure a timely and correct payment of your proceeds from the sales.
16. The sale may take up to 30 working days to close. Sellers must be aware of the time to collect proceeds, clear checks and pay the bills. Only after all the bills are received can the sale be closed. JDA is acting as an agent and seller will be paid after the proceeds have been collected from the buyer. All sales and guarantees are between buyer and seller.
17. **All entries, entry fees, papers and other information must be submitted no later than April 14th, 2017. This ensures a quality catalog and its timely distribution for adequate promotion.**
18. All consignments will receive equal space within the sale catalog. Sale management will determine the content of each lot.
19. A signed floor/ reserve agreement must be completed and returned to the sale management within 12 hours of the auction in order to sell. All lots without a signed floor/ reserve agreement will forfeit selling and the consignor will be responsible for all prorated sale costs.
19. A package of catalogs will be sent to you prior to sale day. If you have not already started, begin promoting this event. Without a combined effort by all, we will not succeed on the level that we would like to see. Contact and encourage buyers from your area to attend.
